

BAC Resolution Declaring SCRB and Recommending Approval

RESOLUTION NO. 061(12-20)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Mechanical Supplies, Parts and Materials consisting of six (6) lots, with an Approved Budget for Contract (ABC) of **SEVEN MILLION SEVEN HUNDRED SIXTY-SEVEN THOUSAND FOUR HUNDRED SIXTY-NINE PESOS AND TWENTY-FIVE CENTAVOS (P7,767,469.25), VAT Inclusive;**

WHEREAS, the sub-ABCs are as follows; **Lot I** – One Hundred Twelve Thousand One Hundred Fifteen Pesos and Ninety-Five Centavos (**P112,115.95**); **Lot II** – Six Million Six Hundred Twenty-Six Thousand Five Hundred Seventy-Six Pesos and Ninety Centavos (**P6,626,576.90**); **Lot III** – One Hundred One Thousand Six Hundred Thirty-Seven Pesos (**P101,637.00**), **Lot IV** – One Hundred Eight Thousand Three Hundred Fifty-Eight Pesos and Seventy-Five Centavos (**P108,358.75**); **Lot V** – Seven Hundred Fifty-Three Thousand Six Hundred Thirty-Six Pesos and Forty Centavos (**P753,636.40**) and **Lot VI** – Sixty-Five Thousand One Hundred Forty-Four Pesos and Twenty-Five Centavos (**P65,144.25**);

WHEREAS, in response to the said posting, only one (1) supplier, **PRIMEGOODS TRADING AND ELECTRICAL SUPPL CO. ("Primegoods")**, obtained/paid for the bid documents and submitted bid documents on November 23, 2020. The proposal of the lone bidder was found to be substantially complying:





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To declare a Failed Bid for Lots I, II, III, and IV and schedule a **RE-BID** to for such requirements.


