RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

**W I T N E S S E T H: That -**

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply and Delivery of One (1) unit Mobile Vertical Lift and has accepted a bid from the SUPPLIER which gave the lowest calculated and responsive bid in the total amount of **ONE MILLION ONE HUNDRED THOUSAND PESOS (₱1,100,000.00)**, VAT inclusive;

- h. the Notification of Award.

In consideration of the payments to be made by the PICCI to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the PICCI to undertake the completion of the delivery in accordance with the Schedule of Requirements of the documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;




