

BAC Resolution Declaring LCRO and Recommending Approval

RESOLUTION NO. 003(01-21)

WHEREAS, the PICC-BAC conducted public biddings, on March 2, 2020 and October 21, 2020, for the **Supply and Delivery of Various Electrical and Electronics Supplies, Parts and Materials (Negotiated Procurement)** consisting of four (4) lots, with an Approved Budget for Contract (ABC) of **TWO MILLION EIGHT HUNDRED SIX THOUSAND NINE HUNDRED FIFTEEN PESOS (P2,806,915.00), VAT Inclusive;**

WHEREAS, the sub-ABCs are as follows; **Lot I** – One Million Four Hundred Forty Thousand Two Hundred Ninety Pesos (**P1,440,290.00**); **Lot II** – Four Hundred Sixty-five Thousand Pesos (**P465,000.00**); **Lot III** – Six Hundred Twenty-Two Thousand Five Hundred Five Pesos (**P622,505.00**) and **Lot VI** – Two Hundred Seventy-Nine Thousand One Hundred Twenty Pesos (**P279,120.00**);

WHEREAS, in response to the said posting, only one (1) offeror, PRIMEGOODS TRADING AND ELECTRICAL SUPPLY CO. ("Primegoods"), submitted offers and were found to be substantially complying:


