RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

and

**WIRELESS LINK TECHNOLOGIES, INC.**, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 544 Florentino Torres St., Sta. Cruz, Manila represented herein by its Corporate Secretary, **ANGELO B. DALISAY**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply, Delivery, Installation and Configuration of Additional Access Point with Fiber Optics CAT6 Cable and Accessories and has accepted a bid from the **CONTRACTOR** in the sum of **FIVE MILLION EIGHT HUNDRED SIXTY-SEVEN THOUSAND ONE HUNDRED SEVENTY-FOUR PESOS AND EIGHT CENTAVOS (P5,867,174.08)**, **VAT Inclusive**;

  - f. Section V – Special Conditions of Contract;
  - g. the Performance Security; and
  - h. the Notification of Award.




