### Invitation to Bid for the Supply and Delivery of Twenty-One (21) Units High Plasma Air Purifier for PICC Rentable Areas/Rooms

1. The *Philippine International Convention Center (PICC)*, through the *Approved Budget for CY 2021*, intends to apply the sum of **TWO MILLION ONE HUNDRED SIXTY-NINE THOUSAND EIGHT HUNDRED THIRTY-THREE PESOS AND FORTY CENTAVOS (Php 2,169,833.40) VAT Inclusive**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Twenty-One (21) units High Plasma Air Purifier for PICC Rentable Areas/Rooms**. Bids received in excess of ABC shall be automatically rejected at bid opening.
2. The *PICC* now invites bids for the above Procurement Project. Delivery of the Goods is required within **SIXTY (60) CALENDAR DAYS**. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from the *PICC-BAC* and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by Prospective Bidders on July 2, 2021 from the given address and website(s) below and *upon payment of a non-refundable fee in the amount of Three Thousand Pesos (Php3,000.00)*. The PICC shall allow the bidder to present its proof of payment for the fees *by furnishing the PICC-BAC a copy of the Official Receipt*.
6. The *PICC-BAC* will hold a Pre-Bid Conference on July 14, 2021 at 10:00 a.m. *Meeting Room 10 (MR-10), 3<sup>RD</sup> Floor Delegation Building, PICC* and/or through videoconferencing/webcasting *via Zoom*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **August 23, 2021 at 10:30 a.m.**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
