BAC Resolution Declaring a Failed Bid

RESOLUTION NO. 012(05-22)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Two (2) Year Contract for the Specialized/Intensive Termite Control and Elimination Services**, with a total Approved Budget for Contract (ABC) of **SIX HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED SEVENTY-NINE PESOS AND EIGHTY-TWO CENTAVOS (P698,479.82), VAT inclusive;**

WHEREAS, in response to the said posting, four (4) bidders obtained/paid for the bid documents, namely: ENVIRONET TOTAL SERVICES, INC. ("Environet"), G & D PEST CONTROL SERVICES ("G & D"), PEST AWAY CORP. ("PAC") and POWERHOUSE PEST CONTROL SERVICES ("Powerhouse"). During the bidding on April 18, 2022, G & D was declared ineligible for failure to submit the SLCC (Single Largest Completed Contract) Form. Environet, Powerhouse and PAC were declared eligible subject to post-qualification and considered their respective bid proposals, as follows:

WHEREAS, PAC, the first-ranked bidder, was declared **INELIGIBLE** for failure to sign/initial each and every page, by the authorized representative the original copy of Section VII (Technical Specification) documents;


WHEREAS, Powerhouse, the second-ranked bidder, was also post-disqualified for failure to submit (1) an electronically filed income Tax Return for CY 2020; (2) the name of a supervisor who has at least a college degree; and (3) proof of ownership or lease contract of the required equipment; and

WHEREAS, Environet, the third-ranked bidder, upon careful examination, validation and verification, of all the eligibility, technical and financial documents as well as the post-qualification documents submitted, was also post-disqualified for failure to submit proof of ownership or lease contract of the required equipment.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare a **FAILED BID** for the abovementioned requirement; and


RESOLVED, FURTHER, that a **RE-BID** be scheduled for such requirement.




