

AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into the MAY 16 2022 day of May 2022 in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

- and -

JAN OWEN MARTIN CONSTRUCTION CORPORATION, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 37-A J. P. Rizal St., Tuktukan, Taguig City and represented herein by its President, **BERNARD D. LEGARDA**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

WITNESSETH: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the **Supply of Labor and Materials for the Re-Waterproofing of the Breezeway, Banquet Hall and Service Pantry Roof-decks** ("the Project") and has accepted bid from the **CONTRACTOR** in the total amount of **FOURTEEN MILLION EIGHT HUNDRED EIGHTY-SEVEN THOUSAND EIGHT HUNDRED NINE PESOS AND TWENTY-ONE CENTAVOS (P14,887,809.21)**, VAT inclusive;

WHEREAS, the PICCI Management has approved the award of the contract for the said project to the **CONTRACTOR**, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the **CONTRACTOR** enter into this Agreement under the following terms and conditions;

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Bid Proposal submitted on April 12, 2022, Eligibility, Technical and Post-Qualification Documents;
 - b. Section VI – Specifications;
 - c. Section VII – Drawings;
 - d. Section III – Bid Data Sheet;
 - e. Section IV – General Conditions of Contract;
 - f. Section V – Special Conditions of Contract (SCC);
 - g. Notice of Award
 - h. Project Schedule/ Work Program and S-curve;
 - i. Project Safety and Health Program signed by the Safety Officer;
 - j. PERT/CPM; and
 - l. Performance Bond.
2. In consideration of the payments to be made by the PICCI to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
