BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 014(06-22)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply of Labor and Materials for the Installation of Casement Windows along Fire Exit Lane of Meeting Rooms 2 to 8 with an Approved Budget for Contract (ABC) of **ONE MILLION SIX HUNDRED FIFTY-THREE THOUSAND SIX HUNDRED FORTY-SIX PESOS AND FORTY-CENTAVOS (P1,653,646.40), VAT inclusive;**


