**ADDENDUM NO. 01**

This Addendum is issued to amend/revise certain provisions of the Bid Documents for the above-captioned procurement. Said amendments are as follows:

I. Section III- Bid Data Sheet has been changed to read as:

- **ITB Clause 5, second paragraph**
  - The Bidder must have completed within the last three (3) years, **one (1) or two (2) contracts that is/are** similar to this requirement, the amount of which shall be at least fifty percent (50%) of the ABC. If the bidder submits bids for two (2) or more lots, the lot with the largest ABC shall be the basis in determining compliance with the required percentage.
- **ITB Clause 20.2**
  - a. Certified Photocopy of the CY **2021** Income and Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (eFPS)

II. Section V- Special Conditions of the Contract have been changed to read as:

- GCC Clause 5
  - Warranty period
    - **Six (6) months warranty after acceptance by PICC authorized representative of the delivered Goods.**

III. Section VI- Schedule of Requirements have been changed to read as:

- LOT II-Supply and Delivery of York Chiller Consumable Materials
  - Full delivery within **one hundred twenty (120)** calendar days from receipt of Notice to Proceed.

IV. Section VII- Technical Specifications have been changed to read as:

- LOT I- Equipment Control Components

- Item no. 7- CONTACTOR W/ ON-DELAY TIMER (OVERLOAD RELAY) BRAND: ALLEN BRADLEY MODEL: 100-A24NG3 **or its equivalent**
- Item no. 8-MAIN CONTACTOR, TYPE GCA-530 COIL 440V 460V/200HP WESTINGHOUSE BRAND **or its equivalent**


