



KNOW ALL MEN BY THESE PRESENTS:

WITNESSETH: That -



WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the **Supply of Labor and Materials for the Installation of Casement Windows Along Fire Exit Lane of Meeting Rooms 2 to 8** (“the Project”) and has accepted bid from the **CONTRACTOR** in the total amount of **ONE MILLION ONE HUNDRED FIFTY-FIVE THOUSAND THIRTY-SIX PESOS AND NINETY-SIX CENTAVOS (P1,155,036.96)**, VAT inclusive;

WHEREAS, the PICCI Management has approved, the award of the contract for the said project to the **CONTRACTOR**, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the **CONTRACTOR** enter into this Agreement under the following terms and conditions;

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

 - b. Section VI – Specifications;
 - c. Section VII – Drawings;
 - d. Section III – Bid Data Sheet;
 - e. Section IV – General Conditions of Contract;
 - f. Section V – Special Conditions of Contract (SCC);
 - g. Notice of Award;
 - h. Project Schedule/ Work Program and S-curve;
 - i. Project Schedule/ Work Program and S-curve;
 - j. Project Safety and Health Program signed by the Safety Officer;
 - k. PERT/CPM; and
 - l. Performance Bond.

2. In consideration of the payments to be made by the PICCI to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;

3. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
