ADDENDUM NO. 01

This Addendum is issued to amend/revise certain provisions of the Bid Documents for the above-captioned procurement. The amendments are as follows:

I. Section III- Bid Data Sheet has been changed to read as:

- ITB Clause 5
 - The Contractor (the company or its officers) must be engaged in the business for the past three (3) years of **supply, repair, and/or restoration of supply/exhaust ventilation or aircon system.**
- ITB Clause 5.3
 - For this purpose, a similar contract shall refer to **supply, repair, and/or restoration** of supply/exhaust ventilation or aircon system.

II. Section VIII-Checklist

 - Note: The Single Largest Completed Contract shall be completed within the last **three (3)** years from the date of submission and receipt of bids, that is similar to the contract to be bid, the amount of which shall be at least fifty percent (50%) of the ABC.
