

A G R E E M E N T



KNOW ALL MEN BY THESE PRESENTS:




WITNESSETH : That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply, Delivery, Installation and Configuration of Additional Access Point with Fiber Optics CAT6 Cable and Accessories and has accepted a bid from the **CONTRACTOR** in the sum of **SIX MILLION SIX HUNDRED SIXTY THOUSAND THREE HUNDRED TWENTY-SIX PESOS AND FIFTY-SIX CENTAVOS (₱6,660,326.56)**, VAT Inclusive;

WHEREAS, the PICCI Management has approved the award of the contract for said project to the **CONTRACTOR**, which offered the single calculated and responsive bid;

NOW, THEREFORE, the PICCI and the **CONTRACTOR** enter into this Agreement under the following terms and conditions;

PARTIES:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Contractor's Bid submitted on December 7, 2022, including the Eligibility, Technical, and Post-Qualification Documents;
 - b. Section VI – Schedule of Requirements
 - c. Section VII – Technical Specifications;
 - d. Section III – Bid Data Sheet;
 - e. Section IV – General Conditions of Contract;
 - f. Section V – Special Conditions of Contract;
 - g. the Performance Security; and
 - h. the Notification of Award.
3. In consideration of the payments to be made by the PICCI to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the PICCI to undertake the completion of the project in accordance with the Scope of Works enumerated in Section VII – Technical Requirements of the bid documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;




