PADILLA**, hereinafter referred to as **“PICCI”**.

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the **Supply of Labor and Materials for the Replacement of Pebble Washout at Loading Dock and Repair of the Waterproofing Membrane of the Reflecting Pond at the Plenary and Reception Halls** (“the Project”) and has accepted bid from the **CONTRACTOR** in the total amount of **SEVEN MILLION FOUR HUNDRED THIRTY-FOUR THOUSAND SIX PESOS AND TWENTY-TWO CENTAVOS (₱7,434,006.22)**, VAT inclusive;




