BAC Resolution Declaring the Second-Ranked Bidder as LCRB and Recommending Approval

RESOLUTION NO. 35(06-23)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Various Housekeeping Supplies**, with a total Approved Budget for the Contract (ABC) of **TWO MILLION THREE HUNDRED THIRTY-FOUR THOUSAND NINE HUNDRED FORTY-FIVE PESOS, VAT inclusive**

WHEREAS, in response to the said posting, two (2) bidders, namely: BLUE MOUNTAIN SAFETY AND INDUSTRIAL PRODUCTS, INC. ("Blue Mountain") and PRIMESOLV TECHNOLOGIES, INC. ("Primesolv"), obtained/paid for the bid documents. Blue Mountain and Primesolv were declared ELIGIBLE and their bid proposals submitted were found to be substantially complying:



WHEREAS, Blue Mountain the first-ranked bidder was post-disqualified for failure to attach a sketch of its office location and submission of samples that are not compliant with PICC specifications;

WHEREAS, upon careful examination, validation and verification, of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by the second-ranked bidder, Primesolv, the same were found in order and its bid has been found to be responsive. As to compliance with and/or responsiveness to the specifications of the items, the results of evaluation, based on the samples submitted by the bidder, were found also complying;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the award to Primesolv, the aforesaid requirement, as the bidder with the Lower Calculated and Responsive Bid whose total offer of ₱2,085,550.00 is within the ABC.
