

BAC Resolution Declaring LCRB and Recommending Award

RESOLUTION NO. 44(07-23)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Re-Bid for the Supply and Delivery of Various Hardware Supplies, Parts and Materials consisting of three (3) lots, with a total Approved Budget for Contract (ABC) of **THREE HUNDRED THIRTY-FIVE THOUSAND TWO HUNDRED ONE PESOS AND FIFTY CENTAVOS (P335,201.50), VAT inclusive;**

WHEREAS, in response to the said posting, two (2) suppliers, namely: VIVA SALES ENTERPRISES ("VSE") and UP-TOWN INDUSTRIAL SALES, INC. ("Up-Town"), obtained/paid for the bid documents. VSE and Up-town were declared Eligible and their bid proposals were as follows:

WHEREAS, upon careful examination, validation and verification by the Technical Working Group (TWG) of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by Up-Town for Lot II, it was post-disqualified for failure of its authorized representative to sign the Section III and Section V of the bid documents;


WHEREAS, upon careful examination, validation and verification by the Technical Working Group (TWG) of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by VSE for Lot V found to be complying and responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the following:

- a) To recommend to the PICC General Manager the award to VSE, which submitted the lone calculated and responsive bid for Lot V, whose total offer of ₱81,786.00, is within the sub-ABC; and
- b) To conduct a **Negotiated Procurement** for Lots II and VI in accordance with Section 53.1 (Two failed bids) of the Revised Implementing Rules and Regulation of Republic Act 9184.
