I. Section III- Bid Data Sheet has been changed to read as:


- ITB Clause 5
 - **e. Contractor must be Department of Environment and Natural Resources (DENR) accredited and/or recognized contractors and transporters of septic and/or other related wastes.**

- ITB Clause 7.1
 - **Sub-contracting is allowed, provided that the sub-contractor is also a DENR accredited and/or recognized contractors and transporters of septic and/or other related wastes.**

- ITB Clause 20.2
 - **d. Certification stating that the contractor or the sub-contractor is a DENR accredited and/or recognized contractors and transporters of septic and/or other related wastes.**
 - **e. Company profile and list of service personnel in the hauling, transport and proper disposal of septic sludge and any other related industrial wastes.**
 - **f. Certificate of Satisfactory Completion & Acceptance of previous PICC projects undertaken within the last two (2) years, if any.**
