KNOW ALL MEN BY THESE PRESENTS:

PADILLA**, hereinafter referred to as **“PICCI”**.

and

PRIMESOLV TECHNOLOGIES CO., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 23 Mc Arthur Highway, Karuhatan, Valenzuela City and represented herein by its President, **CRESENCIA M. MAZO**, duly authorized for the purpose, hereinafter referred to as **“SUPPLIER”**.

WITNESSETH: That -

- f. Section V – Special Conditions of Contract (SCC);
- g. Performance Security; and
- h. Notification of Award.

2. In consideration of the payments to be made by the PICCI to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the PICCI to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract;




