**BAC Resolution Declaring a Failed Bid**

**RESOLUTION NO. 28(06-23)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Re-Bid for the **Procurement of Automatic Liquid Soap Dispenser** with Approved Budget for the Contract (ABC) of **FIVE HUNDRED FOUR THOUSAND NINE HUNDRED PESOS (P504,900.00), VAT Inclusive;** and

WHEREAS, in response to the said posting, three (3) bidders obtained the bid documents namely: COSASDEOFICINA TRADING ("Cosasdeoficina"), EXTREMECLEAN SERVICES AND TRADING CORPORATION ("Extremeclean") and HOSPECO PHILIPPINES INC. ("HPI"). Extremeclean was declared Ineligible on May 29, 2023 due to its (1) Failure to submit the List of On-going and Private Contracts (2) Failure to submit the Single Largest Completed Contracts (SLCC) and (3) Expired Audited Financial Statement (SFS). HPI and Cosasdeoficina were found Eligible and their bid proposals were found to be substantially complying:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the award to Cosasdeoficina, the aforesaid requirement, as the bidder with the Lower Calculated and Responsive Bid whose total offer of P323,000.00 is within the ABC.
