

BAC Resolution Declaring LCRB and Recommending Award

RESOLUTION NO. 47(07-23)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Office Supplies, Various Ink Cartridges and Printing Services consisting of five (5) lots, with a total Approved Budget for Contract (ABC) of **EIGHT HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED NINETY-FOUR PESOS AND ONE CENTAVO (P839,294.01), VAT inclusive;**

WHEREAS, in response to the said posting, only one (1) bidder, NEW WORLD PRINTING CORPORATION ("NWPC"), obtained and paid the bid documents and submitted an application for eligibility on July 24, 2023. The bid proposal of the lone bidder was found to be substantially complying:




