PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **RENATO B. PADILLA**, hereinafter to as **“PICCI”**.

RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE, a cooperative duly organized and existing under the laws of the Republic of the Philippines, with office address at 62B Mapagkawanggawa St., UP Teachers Village, Diliman, Quezon City and represented herein by its Project Manager, **MARK CRISTHIAN VILLARIN**, duly authorized for the purpose, hereinafter referred to as **“CONSULTANT”**.

WITNESSETH: That -

WHEREAS, the **CONSULTANT** was declared the Sole Rated and Responsive Bid that participated in the Public Bidding for Procurement of the Consultancy Services of an Advertising Agency/Public Relations Agency/Media Outfit of **PICCI**, with an Approved Budget for Contract (ABC) of **TWO MILLION FORTY THOUSAND PESOS (₱2,040,000.00)**, VAT inclusive; and

WHEREAS, in the terms and conditions of the consultancy contract, **PICCI** and the **CONSULTANT** have agreed that, in consideration for the **CONSULTANT**’s bid price of **ONE MILLION EIGHT HUNDRED TWENTY THOUSAND PESOS (₱1,820,000.00)**, VAT Inclusive, the duration of the Consultancy Contract shall be one (1) year.

NOW, THEREFORE, **PICCI** and the **CONSULTANT** enter into this Agreement under the following terms and conditions;

1. The following documents shall be deemed to form, and be read and construed as part of this Agreement, viz:
 - a. The Technical and Financial Proposal submitted by the **CONSULTANT** dated November 21, 2023;

 - c. Section III – Bid Data Sheet;
 - d. Section IV – General Conditions of the Contract;
 - e. Section V – Special Conditions of the Contract;
 - f. Section VI – Terms of Reference;
 - g. Notice of Award of Contract and the Bidder’s conforme thereto;
 - h. Performance Security.

2. In consideration for the price of **ONE MILLION EIGHT HUNDRED TWENTY THOUSAND PESOS (₱1,820,000.00)**, VAT Inclusive, to be paid by **PICCI** to the **CONSULTANT**, the **CONSULTANT** hereby covenants with **PICCI** to execute and complete the Consulting Services and deliverables for a period of one (1) year and remedy any defects therein in conformity with the provisions of this contract in all respects; and

3. PICCI hereby covenants to pay the CONSULTANT in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
