PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to as "PICCI".

and

EAST RICHWOOD SAFE COMPANY, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 22 N. Domingo St., Valencia, Quezon City and represented herein by its President, RICHARD G. CAMPOS, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

2. In consideration of the payment to be made by PICCI to the CONTRACTOR, the latter hereby covenants with PICCI to deliver the services required, subject of the public bidding in conformity with the provisions of the SCC; and

3. PICCI shall pay the CONTRACTOR, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC


