

**AGREEMENT**

**KNOW ALL MEN BY THESE PRESENTS:**

This Agreement, entered into this 5th day of January, 2023, in the City of Pasay, Philippines, by and between:

**PHILIPPINE INTERNATIONAL CONVENTION CENTER INC.**, a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **RENATO B. PADILLA**, hereinafter to as **“PICCI”**.

and

**TOYOTA VALENZUELA, INC.**, a company duly organized and existing under the laws of the Republic of the Philippines with office address at 457 Mc Arthur Hi-way Dalandanan, Valenzuela City and represented herein by its Sales Manager, **GUADA MICHELLE CASTRO**, duly authorized for the purpose, hereinafter referred to as **“SUPPLIER”**.

**WITNESSETH: That -**

The total amount of Approved Budget for Contract (ABC) is **FIVE MILLION EIGHT HUNDRED SEVENTEEN THOUSAND SIX HUNDRED FIFTY PESOS (P5,817,650.00)**, VAT inclusive;

2. The following documents shall be deemed to form, and be read and construed as, part of this Agreement, viz:
  - a. The Bid Proposal submitted on December 11, 2023, Eligibility Documents, Technical and Post-Qualification Documents;
  - b. Section VI – Schedule of Requirements;
  - c. Section VII – Technical Specifications;
  - d. Section III – Bid Data Sheet;
  - e. Section IV – General Conditions of Contract;
  - f. Section V – Special Conditions of Contract (SCC);
  - g. Notice of Award; and
  - h. Performance Bond.
3. In consideration of the payment to be made by **PICCI** to the **SUPPLIER**, the latter hereby covenants with **PICCI** to deliver the abovementioned requirements, in conformity with the provisions contained in the approved Technical Specifications;
4. **PICCI** shall pay the **SUPPLIER**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
