

**BAC Resolution Declaring Failed Bid for Lot I**

**RESOLUTION NO. 32(05-24)**

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER – BIDS AND AWARDS COMMITTEE (PICC-BAC) advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply of Regular Housekeeping consisting of two (2) lots, with an Approved Budget for the Contract (ABC) of **THREE MILLION THREE HUNDRED SIXTY-FOUR THOUSAND FOUR HUNDRED THIRTY-ONE PESOS (Php3,364,431.00) VAT Inclusive;**

WHEREAS, in response to the said posting, four (4) bidders obtained and paid for the bid documents, namely: CARE1ST CORPORATION ("Care1st"), PRIMESOLV TECHNOLOGIES CO. ("Primesolv"), BEAU ESSENCE HEALTH AND BEAUTY INC. ("Beau Essence") and JC MAPLE TRADING ("JC Maple"). All were declared eligible during the public bidding on March 25, 2024, except for Beau Essence for failure to attached Secretary's Certificate.

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by JC Maple and Care1st for Lot I – Supply and Delivery of Toilet Tissue Paper, Interfolded Paper Towel and Jumbo Toilet Tissue Paper, both were post-disqualified for the following reasons:

RESOLVED, FURTHER, that a **RE-BID** be scheduled for such requirement


