ADDENDUM NO. 01

 - "k"- Technical **personnel** who is trained in surveillance system Closed Circuit Television (CCTV) and video surveillance, certification must be provided
 - "i"- Technical **personnel** who is trained in Precision Air Conditioning Unit (PACU) System, certification must be provided
 - Item **"m"** has been deleted
 - ITB Clause
 - "c"- Company profile with **organizational chart and sketch of office location;**
 - "e"- **Certification to be issued by the bidder stating that they have a certified product engineer and a certified fiber and copper technician with attached individual manufacturer-issued certificates.**
- II. Section VII- Technical Documents have been changed to read as:
 - III. Warranty and Support
 - **For the duration of the maintenance period, if any of the parts installed in items 3,4,14 and 15, is found to be defective upon examination and testing, the service provide shall repair or replace the defective parts.**

- **As the Maintenance contract is executed on Full Turnkey solution basis, the winning bidder is fully responsible to provide any or all parts and services free of cost if such items/services is inadvertently not specified or part of the contract but those items are essential to provide the intended Datacenter Operational Requirement.**

A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances.
