

BAC RESOLUTION DECLARING LCRB AND RECOMMENDING AWARD
RESOLUTION NO. 21(04-24)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply, Delivery and Installation of Uninterruptible Power Supply (UPS), 3Phase, 20Kva (Server)**, with an Approved Budget for the Contract (ABC) of **ONE MILLION FOUR HUNDRED EIGHTY THOUSAND PESOS (P1,480,000.00), VAT inclusive;**

WHEREAS, in response to the said posting, six (6) bidders namely, AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. ("ASPEX"), P2RO, INC. ("P2RO"), WIRELESS LINK TECHNOLOGIES, INC ("Wireless Link"), LSI LEADING TECH ("LSI"), BE3 POWER SOLUTIONS ENTERPRISE ("BE3 POWER") and DIGI-SPECS I.T. Corp. (Digi-Specs"), obtained and paid the bid documents and submitted applications for eligibility on April 2, 2024. All bidders were declared Eligible except for BE3 which was declared Ineligible for failure to attach its Single Largest Completed Contract (SLCC). The bid proposals of all eligible bidders were found to be substantially complying:


