**BAC RESOLUTION DECLARING SCRB AND RECOMMENDING APPROVAL**

**RESOLUTION NO. 36(05-24)**

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER-BIDS AND AWARDS COMMITTEE (PICC-BAC), on April 3, 2024, caused the publication in the The Manila Times of the Invitation to Bid for the **Supply of Labor and Materials for the Rehabilitation of the Roof of Meeting Room 1** with an Approved Budget for the Contract (ABC) of **SIXTEEN MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND EIGHT HUNDRED NINETY PESOS AND TWENTY-ONE CENTAVOS (P16,968,890.21), VAT inclusive**. Said invitation was also posted in the Phil-GEPS, PICC Website and in a conspicuous place at the premises of the BAC Secretariat;

WHEREAS, in response to the said posting, only one (1) bidder, JAN OWEN MARTIN CONSTRUCTION CORPORATION ("JOMCC"), obtained and paid the bid documents and submitted an application for eligibility on April 29, 2024. The bid proposal of the lone bidder was found to be substantially complying:


