

**BAC Resolution Declaring LCRB and Recommending Award**

**RESOLUTION NO. 39(06-24)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Hardware Supplies, Parts and Materials consisting of seven (7) lots, with a total Approved Budget for Contract (ABC) of **SIX MILLION NINE HUNDRED SEVENTY-SIX THOUSAND FIVE HUNDRED FIFTY-THREE PESOS AND FIFTY CENTAVOS (P6,976,553.50), VAT inclusive;**

WHEREAS, the sub-ABCs are as follows; **Lot I:** Carpentry and Masonry Materials – TWO MILLION TWO HUNDRED FIFTY-SIX THOUSAND TWO HUNDRED TEN PESOS (**P2,256,210.00**); **Lot II:** Masonry Materials – ONE MILLION HUNDRED THREE HUNDRED SIXTY-SIX THOUSAND FIVE HUNDRED NINETY-NINE PESOS (**P1,366,599.00**); **Lot III:** Painting and Varnishing Materials – ONE MILLION SIX THOUSAND NINETY-EIGHT PESOS (**P1,006,098.00**); **Lot IV:** Plumbing Materials – ONE MILLION THREE HUNDRED TWENTY-TWO THOUSAND SEVEN HUNDRED EIGHTY-FIVE PESOS (**P1,322,785.00**); **Lot V:** Metal Materials – TWO HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED EIGHTY-EIGHT PESOS (**P239,288.00**); **Lot VI:** Parts and Tools – ONE HUNDRED FORTY THOUSAND SIX HUNDRED TWENTY-THREE PESOS AND FIFTY CENTAVOS (**P140,623.50**); **Lot VII:** Power Tools and Equipment – SIX HUNDRED FORTY-FOUR THOUSAND NINE HUNDRED FIFTY PESOS (**P644,950.00**);

WHEREAS, in response to the said posting, three (3) bidders, namely: JAN OWEN MARTIN CONSTRUCTION CORPORATION ("JOMCC"), VIVA SALES ENTERPRISES ("VSE") and UP-TOWN INDUSTRIAL SALES, INC. ("Up-Town"), obtained/paid for the bid documents. All were declared Eligible and their bid proposals were as follows:

WHEREAS, upon careful examination, validation and verification by the Technical Working Group (TWG) of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by the first ranked bidders, the BAC, in its meeting on June 6, 2024, found the bid offers submitted by VSE for Lots I, II, III and IV found to be complying and responsive. Up-town bid offer for Lot VI found to be complying and responsive;

- a) Award to VSE, which submitted the lowest calculated and responsive bid for Lots I, II, III and IV, whose total offer of P2,117,437.00, P1,014,594.00, P807,411.00 and P1,211,442.00, respectively, are within the sub-ABC;

- b) Award to Up-town, which submitted the lowest calculated and responsive bid for Lot VI whose total offer of ₱130,025.70, is within sub-ABC;
- c) To recommend for approval by the General Manager of the Philippine International Convention Center the above foregoing findings; and
- d) To declare a Failed Bid for Lots V and VII, and schedule a **RE-BID** to for such requirement.


