**KNOW ALL MEN BY THESE PRESENTS:**

This Agreement, entered into this 22<sup>nd</sup> MAY 2024 2024, in the City of Pasay, Philippines, by and between:

PADILLA**, hereinafter referred to as "**PICCI**".

and

**WIRELESS LINK TECHNOLOGIES, INC.**, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 544 Florentino Torres St., Sta. Cruz, Manila represented herein by its Corporate Secretary, **ANGELO B. DALISAY**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply, Delivery, Installation and Configuration of Additional Access Point (Wi-Fi6) with Fiber Optics CAT6 Cable and Accessories in the Various Areas of the Center and has accepted a bid from the **CONTRACTOR** in the sum of **SIX MILLION SEVEN HUNDRED FIFTY-ONE THOUSAND SEVEN HUNDRED FIFTY-THREE PESOS AND FORTY-NINE CENTAVOS (P6,751,753.49), VAT Inclusive;**

**WHEREAS**, the PICCI Management has approved the award of the contract for said project to the **CONTRACTOR**, which offered the single calculated and responsive bid;

**NOW, THEREFORE**, the PICCI and the **CONTRACTOR** enter into this Agreement under the following terms and conditions;

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. The Contractor's Bid submitted on April 2, 2024, including the Eligibility, Technical, and Post-Qualification Documents;
  - b. Section VI – Schedule of Requirements
  - c. Section VII – Technical Specifications;
  - d. Section III – Bid Data Sheet;
  - e. Section IV – General Conditions of Contract;
  - f. Section V – Special Conditions of Contract;
  - g. Performance Security; and
  - h. Notification of Award.
3. In consideration of the payments to be made by the PICCI to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the PICCI to undertake the completion of the project in accordance with the Scope of Works enumerated in Section VII – Technical Requirements of the bid documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;




