

BAC Resolution Declaring as LCRB and Recommending Approval

RESOLUTION NO. 44 (06-24)

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER – BIDS AND AWARDS COMMITTEE (PICC-BAC) advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Wireless Intercom Headset (Lot I) and Wireless Microphone (Lot II)**, with a total Approved Budget for the Contract (ABC) of **ONE MILLION THREE HUNDRED TWENTY-EIGHT THOUSAND PESOS (Php1,328,000.00) VAT Inclusive;**

WHEREAS, in response to the said posting, two (2) bidders obtained and paid for the bid documents, namely: STAGE CRAFT INTERNATIONAL, INC. ("Stage Craft") and MULTI-LINE BUILDING SYSTEMS, INC. ("Multi-line"). Both were declared eligible during the public bidding on May 2, 2024 and their bid proposals, were as follows:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by Stage Craft, the lone bidder for Lot I – Wireless Intercom Headset, the same were found in order and its bid offer in the amount of ₱498,050.00 was found to be responsive.


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by Multi-Line, first-ranked bidder for Lot II – Wireless Microphone, but was post-disqualified as its brochure submitted was not complying;


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by Stage Craft, for Lot II – Wireless Microphone, the same were found in order and its bid offer in the amount of ₱825,300.00 was found to be responsive.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC Management the award to Stage Craft of the aforesaid requirements as the bidder with the Lone Calculated and Responsive Bid for Lot I whose total offer of ₱498,050.00 is within the ABC and Lot II whose total offer of ₱825,300.00 is within the ABC.


