

BAC Resolution Declaring LCRB and Recommending Award

RESOLUTION NO. 49(06-24)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Electrical and Electronics Supplies, Parts and Materials consisting of four (4) lots, with a total Approved Budget for the Contract (ABC) of **FOUR MILLION EIGHT HUNDRED NINETY-NINE THOUSAND EIGHT HUNDRED PESOS (P4,899,800.00), VAT inclusive;**

WHEREAS, the sub-ABCs are as follows; **Lot I:** Electrical Materials – ONE MILLION THIRTY-SEVEN THOUSAND FOUR HUNDRED THIRTY PESOS (**P1,037,430.00**); **Lot II:** Lighting Materials – THREE MILLION FOUR HUNDRED THIRTY-SIX THOUSAND PESOS (**P3,436,000.00**); **Lot III:** Wires – NINETY-ONE THOUSAND THREE HUNDRED TWENTY PESOS (**P91,320.00**); **Lot IV:** Electronic Materials – THREE HUNDRED THIRTY-FIVE THOUSAND FIFTY PESOS (**P335,050.00**);

WHEREAS, in response to the said posting, two (2) bidders, namely: PRIMEGOODS TRADING AND ELECTRICAL SAUPPLY CO. ("Primegoods") and VIVA SALES ENTERPRISES ("VSE"), obtained/paid for the bid documents. Both were declared Eligible and their bid proposals were as follows:

WHEREAS, upon careful examination, validation and verification by the Technical Working Group (TWG) of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by the first ranked bidder, the BAC, in its meeting on June 13, 2024, found the bid offers submitted by Primegoods for Lots I, II, III and IV found to be complying and responsive.


