

BAC Resolution Declaring as LCRB and Recommending Approval

RESOLUTION NO. 61 (08-24)

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER – BIDS AND AWARDS COMMITTEE (PICC-BAC) advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Twenty-Eight (28) Months Contract for Regular Monthly Pest Control Extermination Services and Colony Elimination of Termites at the Center**, with a total Approved Budget for the Contract (ABC) of **TWO MILLION TWO HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED FIFTY PESOS (Php2,295,650.00) VAT Inclusive;**

WHEREAS, in response to the said posting, four (4) bidders obtained and paid for the bid documents, namely: ENVIRONET TOTAL SERVICES, INC. ("Environet"), POWERHOUSE PEST CONTROL SERVICES, ("Powerhouse"), PEST AWAY CORPORATION ("Pest Away"), POWERHOUSE PEST CONTROL SERVICES ("Powerhouse") and JTO PEST CONTROL SERVICES ("JTO Pest Control"). Environet was declared Ineligible as it submitted insufficient contract amount for Single Largest Completed Contract (SLCC). Powerhouse, Pest Away and JTP Pest Control were declared eligible during the public bidding on May 22, 2024 and their bid proposals, were as follows:


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by, first-ranked bidder, JTO Pest Control and second-ranked bidder, Pest Away, both were post-disqualified as they failed to comply with the PICC Requirements;


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by Powerhouse, third-ranked bidder, the same were found in order and its bid offer in the amount of P2,289,756.00 was found to be responsive.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC Management the award to Powerhouse of the aforesaid requirement as the bidder with the Lowest Calculated and Responsive Bid whose total offer of P2,289,756.00 is within the ABC.


