The Bidder must have completed within the last three (3) years a single contract that is similar to this requirement, the amount of which shall be at least fifty percent (50%) of the ABC.

II. Section VI- Schedule of Requirements have been revised to read as follows:

- Full delivery shall be within **sixty (60)** calendar days from receipt of Notice to Proceed.
