and

NEO-TECH ASIA DISTRIBUTION, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 2F CWI Corporate Center,1050 Quezon Avenue, Quezon City, represented herein by its President, **MR. HECTOR M. LEYEZA**, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

 - g. the Performance Security; and
 - h. the Notification of Award
- 2. In consideration of the payment to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the required services for the Three (3) Year Preventive Maintenance Services of Surveillance and Alarm System subject of the public bidding in conformity with the provisions of the SCC and with a contract effective seven (7) days after the receipt of Notice to Proceed; and
- 3. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in Clause 11.3 of the SCC.
