PADILLA, hereinafter to as "PICCI".

and

**POWER HOUSE PEST CONTROL SERVICES,** a company duly organized and existing under the laws of the Republic of the Philippines with office address at 2422 R. Fenandez St., Gagalangin, Tondo, Manila and represented herein by its General Manager/Owner ANNA MARIE M. ESCOBER, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

## WITNESSETH: That-

WHEREAS, PICC, through its Bids and Awards Committee (BAC), invited Bids for a Twenty-Eight (28) — Months Contract for Regular Monthly Pest Control Extermination Services and Colony Elimination of Termites at the Center and has accepted a bid from the CONTRACTOR which gave the lowest calculated and responsive bid in the total amount of TWO MILLION TWO HUNDRED EIGHTY-NINE THOUSAND SEVEN HUNDRED FIFTY-SIX PESOS (₱2,289,756.00), VAT inclusive;

  - h. Performance Security; and
  - i. Notification of Award.
- 2. In consideration of the payments to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the services required under the Twenty-eight (28) months contract subject of the public bidding in conformity with the provisions of the SCC; and
