

AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this 11th day of September 2024 in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to as "PICCI".

- and -

KING N JET RUGS, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at Unit 2407 Pioneer Highlands, Madison cor. Pioneer St. Mandaluyong City and represented herein by its President/General Manager, LITA L. ONG, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply of Labor, Materials and Installation of Roller Blinds at the Summit Halls C, D, E, F and G Service Hallway, 2/F Windows and Exits, Executive Offices, Corporate Boardroom and Leaders Hall and has accepted bid from CONTRACTOR in the total amount of ONE MILLION EIGHT HUNDRED SEVENTY-FOUR THOUSAND FIVE HUNDRED NINETY-ONE PESOS (P1,874, 591.00), VAT inclusive; and

WHEREAS, the PICCI Executive Committee has approved the award of the contract for said project to the CONTRACTOR, which offered the lower calculated and responsive bid.

NOW, THEREFORE, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

- b. Section VI – Schedule of Requirements;
- c. Section VII – Technical Specifications;
- d. Section III – Bid Data Sheet;
- e. Section IV – General Conditions of Contract;
- f. Section V – Special Conditions of Contract;
- g. the Performance Security; and
- h. the Notification of Award

2. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;






