I. Section III- Invitation to Bid has been revised to read as:

- ITB 5.3
  - For this purpose, a similar contract shall refer to the production and delivery of tailored/sewn clothing materials (e.g. uniforms, beddings, curtains, chair/table & skirting, and furniture covers).
    - a. The Bidder must have completed within the last three (3) years, **one (1) or two (2) contract/s that is/are similar to the abovementioned requirement, the amount of which shall be at least twenty-five percent (25%) of the ABC.**

**In case the bidder submits 2 contracts, the largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.**
