### **Invitation to Bid for the Three (3) – Year Subscription of 210mbps Internet Bandwidth Speed**

1. The *Philippine International Convention Center (PICC)*, through the *Approved Budget for CY 2024 and Multi-Year Contracting Authority (MYCA)*, intends to apply the sum of **TWO MILLION THREE HUNDRED SEVEN THOUSAND SIX HUNDRED PESOS (Php2,307,600.00) VAT Inclusive**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Three (3) – Year Subscription OF 210mbps Internet Bandwidth Speed (PICC APP 2024–UP-06)**.
2. The *PICC* now invites bids for the abovementioned requirement. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the abovementioned requirement. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Bids received in excess of ABC shall be automatically rejected at bid opening.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from the *PICC-BAC* and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by Prospective Bidders starting October 11, 2024 from the given address and website(s) below *and upon payment of a non-refundable fee in the amount of Three Thousand Pesos (Php3,000.00)*. The *PICC* shall allow the bidder to present its proof of payment for the fees *by furnishing the PICC-BAC a copy of the Official Receipt*.
6. The *PICC-BAC* will hold a Pre-Bid Conference on *October 21, 2024 at 10:00 a.m. at Function Room B, 2<sup>nd</sup> Floor Secretariat Building, PICC* and/or through videoconferencing/webcasting *via Zoom/Google Meet*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **November 11, 2024 at 2:00 p.m.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **November 11, 2024, at 2:30 p.m.** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
